Building Stewardship is an educational program with the objective of presenting the components of an antibiotic stewardship program that will enhance patient care and safety, with the potential to reduce antibiotic resistance and cost. The program consists of a one-day conference, with pre- and post-session audioconferences, and pre-meeting readings. It brings together experts in the areas of clinical use of antibiotics, pharmacology, antibiotic susceptibility testing and program management to share evidence-based approaches to antibiotic stewardship in acute care hospitals.

The cost of the program is \$80.00 per person, which includes conference materials, breakfast, lunch, two audioconferences and continuing education credits.
